Sub: - **Submitting additional items for the Formal Meeting to be held with BSNLEU - req.**

We request you to kindly consider to include the following item, for discussion in the forthcoming Formal Meeting with BSNLEU. Since this item is also connected with the transfers and postings of JEs, which we have already taken up, we request that, this item may also be included for the meeting.

***Implementing intra-circle transfers of JEs in NE-II circle.***

The North East-II circle consists of remote and far-flung districts of Arunachal Pradesh, Manipur and Nagaland. Hence, the Non-Executives, especially JEs, who are posted in the far-flung regions of NE-II circle, face certain specific difficulties. Hence, keeping in view of these problems, the circle administration of NE-II circle has laid down certain guidelines, vide it's letter no.CGMT/NE-II/Admn/Trfs & Postg/Gr. C&D/Vol-II/14-15/68 dated 31.01.2019, in respect of the transfers and postings of DR JEs.

As per para (1) of the aforementioned CGMT letter, the JEs are eligible to apply for intra-circle transfer of his/her choice SSA, after completion of TWO YEARS of service in any particular SSA in NE-II Telecom Circle. As per this provision contained in the CGMT letter, certain JEs have applied for transfer to other SSAs of NE-II circle. They have applied for the transfers, after completing TWO YEARS of service in the SSA where they are posted.

The number of JEs working in NE-II circle as on 01.05.2021, are as follows:-

Arunachal Pradesh	37
Nagaland	25
Manipur	18
Circle Office	4
Total =	84

Out of these 12 JEs have applied for transfer to Manipur SSA and one JE applied for transfer to Nagaland.

All the 13 JEs, who have applied for transfer, have already completed two years of service. However, their request for intra-circle transfers have not been considered by the Circle Administration. We request that their transfer request may kindly be considered.
