A meeting of the representatives of BSNLEU, AIBDPA and BSNL CCWF was held online on 17.04.2021. The participants of the meeting are as follows:-

Veteran leader and President of AIBDPA, Com.Ananta Bhattacharjee, presided over the meeting.

Com.P.Abhimanyu, GS, BSNLEU, welcomed everyone and briefly reported on the present status of important issues. He also explained in detail about the efforts being taken by BSNLEU on the Wage Revision issue and the various details connected with that. He emphasized the need for the formation of a Coordination Committee of BSNLEU, AIBDPA and BSNL CCWF for effectively implementing the campaigns / agitations, being called on by these organisations.


All the comrades who participated in the discussion expressed their serious concern over the undue delay in the launching of 4G service by BSNL. Com.K.G. Jayaraj, welcomed the decision to form the CoC and stated that the stand of the government on wage revision and pension revision was not justified. He urged that struggles should be organised incorporating other important issues also, like settlement of medical claims, retrenchment of contract workers and denial of their wages.

Com.V.A.N. Namboodiri, President, BSNL CCWF stated that we have to continuously mobilise the support of the people, in favour of BSNL's revival. He expressed his serious concern over the massive retrenchment of contract workers.


Com.Animesh Mitra, Secretary General, BSNL CCWF, insisted that the issues of the contract workers should be taken up seriously and insisted that some campaign programme should be started.

The meeting also discussed in detail about the issues to be taken up by the CoC and also the agitational programmes. However, keeping in view the raging second wave of COVID-19, it is decided to wait for some time. The meeting strongly demanded that all the BSNL employees should be treated as frontline workers and should be vaccinated on a priority basis.

The meeting unanimously decided to form the Coordination Committee of BSNLEU, AIBDPA and BSNLCCWF. The meeting elected Com.K.G.Jayaraj, GS, AIBDPA, as the Chairman, Com.P.Abhimanyu, G S, BSNLEU, as the Convenor and Com.Animesh Mitra, SG, BSNL CCWF, as the Joint Convenor. The meeting decided that this Coordination Committee should be formed at the circle and district levels also, in the similar pattern.
