Sub: - **Non-fulfilment of the assurances given regarding the holding of various LICEs of the Non-Executives - req.**

We wish to draw your kind attention to the subject mentioned above.

In the talks held between the AUAB and the CMD BSNL on 27.10.2021, the Management Side assured the AUAB that, all the LICEs of the Non-Executives would be held without delay, for which notifications would be issued by 30.11.2021.

However, we regret to inform you that, this assurance has been watered-down by the Management. On 30.11.2021, the Establishment Branch of the Corporate Office issued a letter to all the CGMs, calling for the strength of employees, belonging to various categories viz., SC/ST/OBC. It is stated in the letter that, this is for holding the LICEs of JTO(T), Junior Engineer and Telecom Technician.

We wish to state that, there are many other LICEs for the Non-Executives, like JAO, JTO(OL), etc. However, no initiative has been taken for holding these LICEs.

Further, the Corporate office has just called for some inputs from the circles. However, notifications for holding the LICEs are not yet issued. This is nothing but watering down the assurance given on 27.10.2021, regarding holding the LICEs.

In view of the foregoing, we earnestly urge upon you to kindly take meaningful action for holding all the LICEs of the Non-Executives without further delay.
