Sub: - **Fixing the date for conducting JE LICE offline for the Recruitment Year 2017-18 and levying of exam fee - req.**

We wish to bring the following to your kind notice, for favour of necessary intervention.

In the 37<sup>th</sup> meeting of the National Council, held on 20.11.2018, the Secretary Staff Side, in his initial remarks, drew the kind attention of the Chairman of the National Council, to the issue of holding the JE LICE as an “off-line” exam.

The Secretary, Staff Side, citing the poor results of the last JE LICE, which was held as an “on-line” exam, requested the Chairman of the National Council, the Director (HR), to conduct the exam as an “off-line”.

The Chairman of the National Council was kind enough to consider the demand of the Secretary, Staff Side. Accordingly, it was decided to conduct the JE LICE as an “off-line” exam. However, it is regrettable to note that no date for the JE LICE has been announced by the Management so far, for the Recruitment Year 2017-18. As a result, there is a lot of frustration among the aspiring candidates.

Further, we have to submit that the Management is fixing examination fee for the internal departmental promotional exams, from Non-Executive to Non-Executive like Telecom Technician (TT), JE, etc, which are not online exams. In this regard, we have already written to the CMD BSNL, vide letter no. cited under reference (ii) above. But so far no decision is taken by the Management.

In view of the foregoing, we request you to kindly look into the above issues. We request you to ensure that the JE LICE for the Recruitment Year 2017-18 is held immediately and that no exam fee is fixed for the same.
