Sub: - **Non-implementation of the CGMT order on intra-circle transfers of JEs in NE-II circle - seeking your kind intervention - req.**

We wish to bring the following to your kind notice, on the subject mentioned above, for favour of your intervention and for necessary action.

The North East-II circle consists of remote and far-flung districts of Arunachal Pradesh, Manipur and Nagaland. Hence, the Non-Executives, especially JEs, who are posted in the far-flung regions of NE-II circle face certain specific difficulties. Hence, keeping in view of these problems, the circle administration of NE-II circle has laid down certain guidelines, vide it's letter no.CGMT/NE-II/Admn/Trfs & Postg/Gr. C&D/Vol-II/14-15/68 dated 31.01.2019, in respect of the transfers and postings of DR JEs.

It is needless to state that, these guidelines have been laid down by the NE-II circle administration, after discussion with the Union. As per para (1) of the aforementioned CGMT letter, the JEs are eligible to apply for intra-circle transfer of his/her choice SSA, after completion of TWO YEARS of service in any particular SSA in NE-II Telecom Circle. As per this provision contained in the CGMT letter, certain JEs have applied for transfer to other SSAs of NE-II circle. They have applied for the transfers, after completing TWO YEARS of service in the SSA where they are posted.

However, it has been brought to the notice of our All India Union, by the NE-II circle union that, the requests of the JEs have not been considered for the past many years and that, those JEs are suffering extreme hardship. It is needless to state that the JEs are getting frustrated and demotivated which will certainly have it's reflection in their output. We also wish to draw your kind attention that the NE-II circle union of BSNLEU has written a number of letters to the CGM, NE-II circle. However, no action has been taken in this regard by the CGM, NE-II circle.

In view of the foregoing, we would like to request you to kindly intervene in this matter and to ensure that the JEs who have applied for transfer to other SSAs of NE-II circle, are considered without further delay.
