Sub: - **Issuing Presidential Orders to the employees recruited by the DoT and sent for training prior to 01.10.2000 – non-implementation of the Supreme Court judgement – req.**

Ref: - **BSNLEU letter no. BSNLEU/511(Rectt.) dated 31.07.2023.**

With reference to the letter cited above, we wish to bring the following to your kind notice for favour of necessary action.

BSNLEU, vide letter cited under reference, has already demanded that the order of the Hon'ble Supreme Court of India, delivered on 26th July, 2023, on the above mentioned subject should be implemented.

The case relates to the officials who were recruited on Compassionate Grounds by the DoT and were sent for pre-appointment training before the formation of BSNL, i.e., 01.10.2000. It will not be out of context to state that, the Hon'ble CAT, Jaipur, Hon'ble CAT, Chandigarh, Hon'ble High Court of Rajasthan and Hon'ble High Court of Kerala have also given the judgement that 'the officials recruited by the DoT and sent for pre-appointment training, prior to the formation of BSNL should be issued with Presidential Order.

Thereafter, the Hon'ble Supreme Court of India has delivered judgement on 26.07.2023, upholding the judgements delivered by the Hon'ble High Courts. It is going to be 3 months since the Hon'ble Supreme Court delivered it's judgement. The officials who will be issued with Presidential Orders, based on the order of the Hon'ble Supreme Court, are eagerly awaiting implementation of the same.

In view of the foregoing, we earnestly appeal to you to kindly take necessary action for the early implementation of the order of the Hon'ble Supreme Court dated 26.07.2023.
