Sub: - **Non-declaration of the JTO LICE results of Punjab circle – requesting to immediately declare the results as per the DoP&T letter dated June 15, 2018 - reg.**

Ref: - **DoP&T letter no.F.No.36012/11/2016-Estt.(Res-I) {Pt-II} dated June 15, 2018.**

We wish to bring the following to your kind notice, for favour of necessary action.

BSNLEU is continuously taking up the issue of non-declaration of JTO LICE results in Punjab circle. The issue was also discussed in the Formal Meeting held with the Director (HR) in January, 2020, August, 2020 and in June, 2021. However, the issue still remains pending.

The affected JEs of Punjab circle are very much frustrated and demotivated. In view of this, the circle union of BSNLEU, Punjab circle, is organising a massive dharna in front of the CGM Office on 12.07.2021. If the issue gets dragged on without any solution, the unrest is likely to aggravate in future. In view of this, we urgently solicit your serious attention into this matter.

In this connection, we would like to draw your kind attention to the DoP&T letter, cited under reference, which clearly states two things. The letter quotes the order of the Hon'ble Supreme Court in the SLP(C) No.31288/2017 dated 05.06.2018 which states that: -

- (i) ***the SLP, which remains pending in the Supreme Court, does not debar the Government from making promotions.***

Further, the DoP&T letter also quotes the order of the Hon'ble Supreme Court, in the SLP(C) No.30621/2011 dated 17.05.2018, which reads thus: -

- (ii) ***“..It is directed that the pendency of this Special Leave Petition shall not stand in the way of Union of India taking steps for the purpose of promotion from ‘reserved to reserved’ and ‘unreserved to unreserved’ and also in the matter of promotion on merits.....”***

As per the aforementioned DoP&T letter, the issue of declaring JTO LICE results in Punjab circle can very well be resolved without further delay. Hence, we urge upon you to kindly intervene on this matter and to find a solution to the problem without further delay.
