Sub: - **Non-declaration of the additional IDA, that has become due w.e.f. 01.10.2020, 01.01.2021, 01.04.2021 and 01.07.2021- req.**

Ref: - **DPE letter no.W-02/0039/2017-DPE(WC)-GL-XVI/20 dated 19<sup>th</sup> November, 2020.**

With reference to the letter cited above, we would like to bring the following to your kind notice, for favour of necessary action.

The DPE, vide letter cited under reference, had decided that the IDA instalments that become due w.e.f. 01.10.2020, 01.01.2021 and 01.04.2021 shall not be paid. Further, it is also stated in the letter that, the above mentioned IDA instalments would be paid w.e.f. 01.07.2021, after decision is taken by the government to release the IDA instalments.

In this connection, we would like to bring to your kind notice that, the government has already taken decision to release the IDA instalments, that have been with held. However, the DPE has not sent communication to the CPSEs, notifying the quantum of IDA that has become due w.e.f. 01.10.2020, 01.01.2021, 01.04.2021 and 01.07.2021. It is already 31<sup>st</sup> of July, 2021 and still the quantum of IDA, that has become due from the above mentioned dates, has not been informed by the DPE to the CPSEs.

Due to this, the CPSEs, including the BSNL, are unable to make payment of the additional IDA instalments that has become due up to 01.07.2021. It is also not out of context to mention here that, the DA instalments of the Central Government employees had also been frozen. However, after the announcement of the government, now the quantum of increase in the DA for the Central Government employees has already been announced.

In view of the foregoing, we earnestly urge upon you to kindly ensure that, the IDA increase that has become payable w.e.f. 01.10.2020, 01.01.2021, 01.04.2021 and 01.07.2021 is communicated to the CPSEs, without further loss of time.
