We wish to bring to your kind notice that, the BSNL employees are very much agitated over the unprecedented delay in the revision of IDA w.e.f. 01.01.2026. In the meanwhile, one more revision of IDA has also become due w.e.f. 01.04.2026. The BSNL employees have already organised protest actions such as Blackbade Wearing on 23.04.2026 : Submission of memorandum to the CCAs on 24.04.2026 and Twitter Campaign on 27.04.2026.

It is regrettable to note that, inspite of the aforementioned agitational programmes organised by the Unions and Associations of BSNL, revision of IDA w.e.f. 01.01.2026 is yet to be implemented. Under these circumstances, a meeting of the All Unions and Associations (AUAB) was held on 07.05.2026, wherein it has been decided to organise the following protest action:-

**20.05.2026 - Organising of Protest-Chain programme infront of all BSNL offices and Exchanges and also participating in the dharna programme being organised by the Pensioners' Associations.**

We once again earnestly seek your kind intervention for the early settlement of the IDA revision w.e.f. 01.01.2026, as well as early implementation of the IDA revision w.e.f. 01.04.2026.




