Sub: - **Requesting to hold the JAO LICE immediately and also to incorporate the amendments to the JAO RR, as sought by BSNLEU – req.**

Ref: - **BSNLEU letter no.BSNLEU/527 (JAO) dated 27.10.2021**

With reference to the letter cited above, we would like to bring the following to your kind notice for favour of necessary action.

The JAO LICE is not held for the past many years. In the meeting held between the AUAB and the CMD BSNL on 27.10.2021, it has been assured by the CMD BSNL that all the LICES of the Non-Executives would be held promptly. In this connection, we request you to kindly take the needful action for holding the JAO LICE at the earliest.

Further, we would also like to bring to your kind notice that, BSNLEU is demanding to incorporate certain amendments to the JAO Recruitment Rules. The amendments already sought by BSNLEU are as follows: -

- (1) All the employees who are having the requisite qualification as per the JAO RR, should be allowed to appear in the JAO LICE, without insisting for the condition that, they should have completed 5 years of service in the NE 6 pay scale.
- (2) The maximum age limit for appearing in the JAO LICE should be increased from 53 years to 55 years, as in the case of JTO LICE.
- (3) The cut-off date for the calculation of vacancies should be 01st July, instead of 01st January, as in the case of other LICES.

As regards the amendments to be incorporated to the JAO RR, the matter has already been discussed with the CMD BSNL and the GM (EF). The CMD BSNL has kindly consented to settle this issue at the earliest.

Hence, we earnestly urge upon you to kindly take the needful initiative for the early incorporation of the amendments to the JAO RR, and also for holding the JAO LICE without further delay.
