Sub: - **Seeking review in the decisions of the Corporate Office, regarding Consolidation of Business Areas – req.**

We wish to bring the following to your kind notice, for favour of appropriate action.

It has been brought to our notice that, in Assam circle, the Nagaon SSA and Tezpur SSA are being brought under one single Business Area. This is not acceptable to the Executives and Non-Executives working in both the SSAs for the following reasons.

Tezpur SSA is having six big revenue districts and it is located in the North Bank of the river Brahmaputra. Whereas, the Nagaon SSA is located on the Southern side of the river Brahmaputra, with for big revenue districts. Due to the administrative, as well as geographical reasons, there will be many difficulties, if both these big SSAs are brought under a single Business Area.

After the decision of the corporate Office is communicated for bringing both Tezpur and Nagaon SSAs under a single Business Area, the employees of both the SSAs are agitating against the decision. A number of representations have been made to the CGMT, Assam Circle, to the Hon'ble Members of the Parliament and to the Hon'ble Chief Minister of Assam, requesting to drop the above mentioned decision.

Under these circumstances, it is not advisable for the Corporate Office to proceed with the decision of bringing Tezpur and Nagaon SSAs under a single Business Area. In view of this, we request you to kindly review the decision and to drop the same.

We also wish to bring to your kind notice that, BSNLEU, vide it's letter number BSNLEU/503(CDR) dated 30.09.2020, addressed to the GM (Restg.), BSNL Corporate Office, has already requested to bring the Cuddapha SSA under the Tirupati Business Area, instead of putting it under Ananthapur Business Area. However, no response has been received from the Restructuring Branch on this matter.

In view of the foregoing, we request you to kindly look into both the decisions and to do the needful for reviewing them. We hope that our requests would be looked into and that, appropriate decisions would be taken at the earliest.
