With reference to the above, we wish to bring the following to your kind notice, for favour of necessary action.

It is already 5<sup>th</sup> of April, 2021 and as usual, the salary for the month of March, 2021, has not been paid to the employees. We wish to bring to your kind notice that, BSNLEU is repeatedly urging upon the Management to honour the time schedule laid down by it, for the payment of salary to the employees. BSNLEU has continuously taken up this matter, vide letters cited under reference.

When the General Secretary, BSNLEU, met the CMD BSNL last time, it was once again insisted that, the Management should pay salary to the employees on the last date of every month, keeping in view the improvement witnessed in the revenue collections of the Company. On that occasion, the General Secretary, BSNLEU, pointed out that, the chain of belated payment of salary could be broken, if the Management came forward to make payment of the salary on time for one month. However, it is regrettable to note that, the Management is not having the inclination of doing it.

In this connection, various circle unions of BSNLEU have drawn the attention of the Central Head Quarters of our Union, to the positive development in the collection of revenues of the Company, for the month of March, 2021. It has been brought to our notice that, the revenue collections have exceeded Rs.3,000 crore in March, 2021. It is needless to state that, this opportunity should be utilised by the Management to immediately release funds for the payment of salary for the month of March, 2021.

If salary for the month of March, 2021 is paid in this week, then, naturally, the salary for the month of April, 2021 could be paid on 30th April, 2021 itself and thereby the chain of belated payment of salary could also be broken. Thereby, the BSNL Management can save itself from the ignominy of not paying salary on time to it's employees, for more than a year now. Hence, we earnestly urge upon you sir, to kindly do the needful in this connection.
