Sub: - Denial of voting right to two officials on deputation at Tirupati, Andhra Pradesh circle – seeking immediate intervention - reg.

As per the BSNL CO letter no.BSNL/5-1/SR/2018 dated 28.08.2019, ballot papers, for casting postal votes, should be sent to the voters 15 days prior to the polling date.

However, it had been brought to our notice that, this time schedule was not followed in Andhra Pradesh circle and that there was delay in sending ballot papers to the officials on deputation. The matter was discussed by me, with Shri A.M. Gupta, GM (SR), BSNL CO., on 05.09.2019 itself. The GM (SR), assured that the ballot papers would be sent by hand, so that the officials on deputation would get the ballot papers on time.

I believed that this assurance would be implemented. However, it has been brought to our notice that two officials, on deputation at Tirupati, viz., Ms. I. Lakshmi, JA, Vijayawada, on deputation at Tirupati and Ms. K.V. Radha, AOS, on deputation at Tirupati, from Hyderabad, did not receive the postal ballot papers.

The above matter has been immediately taken to the notice of the The Chief Returning Officer and the GM(SR), BSNL CO., through Whatsapp. However, it is learnt that no intervention has been made by the Corporate Office and both the above mentioned officials are denied of their voting rights.

BSNLEU records it's serious objection for this lapse on the part of the Corporate Office. Eventhough, the lapse was pointed out 10 days ago, the Corporate Office has not taken any remedial action.

In view of the foregoing, your kind intervention is requested for necessary remedial action so that the above mentioned officials are not denied of their voting right.
