Sub: - **Immunity from transfers to the office bearers of Recognised Unions – non-implementation of the Corporate Office instructions in Gujarat circle - req.**

Ref: - **CGM, Gujarat letter no.DGM(A)/CO-AM/Exe.Trfr/2020/22 dated 01.06.2020.**

We wish to bring the following to your kind notice for favour of necessary action.

The Corporate Office has issued instructions, granting immunity from transfers to certain identified office bearers of the Recognised Unions. This facility has been extended at the All India, Circle and District levels. As a matter of fact, this facility has been extended to the Recognised Unions in BSNL, based on the instructions of the DOT.

However, it is a matter of regret that these instructions of the Corporate Office are not being implemented in Gujarat circle. We have sought the intervention of the Corporate Office on an earlier also, on this matter. Once again, this violation is taking place in Vadodara district. Shri Anand Narayan Singh, JTO, who is the District Secretary of BSNLEU, has been transferred to Amreli district vide the letter number cited under reference.

The Gujarat circle Administration very well knows that, being the District Secretary of BSNLEU, which is the Main Recognised Union in BSNL, Shri Anand Narayan Singh is having immunity from transfers. In spite of it, this transfer order has been issued, with the view to harass Shri Anand Narayan Singh.

We have reason to believe that, this transfer order has been issued at the behest of certain vested interests in Vadodara district. This issue has already been taken up by the Circle Union of BSNLEU, with the Circle Administration, Gujarat, vide letter number BSNLEU/GJ/Immunity-Tras/2020-21/02 dated 02.06.2020. However, the issue has not been resolved yet.

In view of the foregoing, we request you to kindly intervene in this matter and to ensure that the Corporate Office orders, on the issue of immunity from transfers, is implemented in Gujarat circle.
