Sub: - **COVID-19 guidelines issued by Maharashtra State Government – implementation of the same in BSNL, Maharashtra - req.**

We wish to bring the following to your kind notice for favour of information and necessary action.

The COVID-19 pandemic is spreading fast in Maharashtra circle. In one single day alone, i.e., on 04.04.2021, 57,000 new COVID-19 cases are reported in Maharashtra circle. Many of our employees, including top officers, have tested positive for COVID-19. The spread of this dreaded disease has created fear among the employees.

With the view to contain the spread of COVID-19 in Maharashtra, the state government had issued certain guidelines. These guidelines include, "working of offices with 50% attendance", "work from home", etc. The Maharashtra circle BSNL administration has written to the Corporate Office, vide their letter cited under reference, seeking permission for implementing the guidelines issued by the State Government in BSNL, Maharashtra.

The BSNL employees working in Maharashtra are a part and parcel of that state. Hence, whatever guidelines issued by the Maharashtra State Government, for the containment of COVID-19, should be made applicable to the BSNL employees also, who are working in that circle.

In view of the foregoing, we request you to kindly accord necessary approval, as sought by the Maharashtra BSNL administration, to safeguard the employees.
