Sub: - **Preponement of the date of regularisation of Shri S. Venkateshwara Rao, from 01.04.1993 to 01.12.1982- reg.**

Ref: - (1) **Hon'ble Court order dated 07.08.2019 in CA 5633/2008 in case of Shri S. Venkateshwara Rao, Ex-TM, Andhra Pradesh Circle, now working as JE, STP, Vijayawada.**

With reference to the Hon'ble Supreme Court order cited above, we wish to draw the following to your kind notice, for favour of expeditious action.

This case relates to the preponement of the date of regularisation of Shri S. Venkateshwara Rao, from 01.04.1993 to 01.12.1982. Shri S. Venkateshwara Rao, was engaged as casual mazdoor in the DoT on 01.07.1979, as per the original muster roll, attested by the AGM (Admin.), Vijayawada. However, this was contested by the department. Shri S. Venkateshwara Rao was regularised in the Department of Telecommunication from 01.04.1993.

The dispute was going on for a pretty long period. Finally, the Hon'ble Court has ordered that the case of regularisation of Shri S. Venkateshwara Rao, should be preponed from 01.04.1993 to 01.12.1982. Based on this, the CGMT, Andhra Pradesh circle, vide it's letter no.APCO-11/14(18)/1/2021-ADMIN-APCO dated 24.08.2021, has recommended that the date of regularisation of Shri Venkateshwara Rao should be preponed from 01.04.1993 to 01.12.1982.

Since, this case relates to the DoT period, the BSNL Corporate Office has referred the case to the DoT for necessary approval. The case has already dragged on for a pretty long period and justice has been denied to Shri S. Venkateshwara Rao In view of this, we earnestly request you to kindly look into the matter and to do the needful, so that the requisite approval is granted by the DoT without further delay.
